October: Crassulaceae 1

subfamilies Cotyledonoideae and Kalanchoideae Tylecodon, Cotyledon, Kalanchoe

November: Crassulaceae 2

Crassula, Adromischus, Aeonium

CACTUS

September: Echinocactus I, Astrophytum

(subfamily Cactoideae, tribe Echinocacteae) Astrophytum ONLY

October: Echinocactus II Group


(subfamily Cactoideae, tribe Echinocacteae) Echinocactus, Ferocactus, Leuchtenbergia, Stenocactus (Echinofossulocactus), Ariocarpus, Obregonia, Aztekium

November: Epiphytic Group

(subfamily Cactoideae, tribes Hylocereae, Rhipsalideae) Pereskia, Maihuenia, Pereskiopsis, Opuntia, Cereus, Carnegiea, Cephalocereus, Esposta
